## Terms and conditions

  - a. Property agents must provide StorHub Referral ID and Property Agent Identification, partners and movers must provide the StorHub Referral ID and name card for subsequent referrals, otherwise the referral will not be considered valid.

## Payment

2. Payment will be paid out monthly within 14 working days upon verification from StorHub and yourself.
